Treasurer Report

- School store recently purchased t-shirts, hoodies, etc. Will be at 6th grade lunch, prospective parents events.
- Discussion of directories expense. \$3200 is a marker for 2015-16. Tabled discussion of revising printing cost on budget until January. Will have extra funds for 2014-15.
- Direct School Expense change. Proposal to reallocate from Technology to Principal Discretionary line item to cover additional staff holiday cash. Total DSE will not change. See email detail from 12/3/14. Note this is considered a one-time, increased staff distribution for 2014. Purpose is to thank staff and acknowledge that the tax increase did not pass in November as hoped. Approved \$50 to each staff member. Distribution 12/19.

Principal Report

- IXL Math: PTO will pay \$7728 directly. No sales tax. Purpose is to have software available in preparation for one-to-one technology rolling out in 2/15. Purchasing a one-year license for each AG student, so will be an ongoing expense to consider.
- Kevin Washburn needs new print head on poster maker. \$600+ purchase. Agreed to fund and to place under technology line item in DSE since is hardware purchase.
